Items returned due to customer's error or overstocking are subject to a 20% handling charge. Any item returned for credit must be sealed in its original package, unmarked, within expiration date and have been stored and shipped in compliance with USP drug monographs, FDA guidelines, the manufacturer's, and any other applicable requirements, which customer may be require to certify. Dated products, refrigerated products, special order products and products with opened containers or packaging are not returnable unless otherwise agreed to by *Priority Pharmaceuticals*. *Priority Pharmaceuticals* is not responsible for merchandise returned without authorization and reserves the right to reject the same and charge the customer for any shipping or other charges incurred.
